Known for a commitment to sustainability, the Company was the first major U.S. coffeehouse to serve 100% Rainforest Alliance Certified™ coffees and espresso. 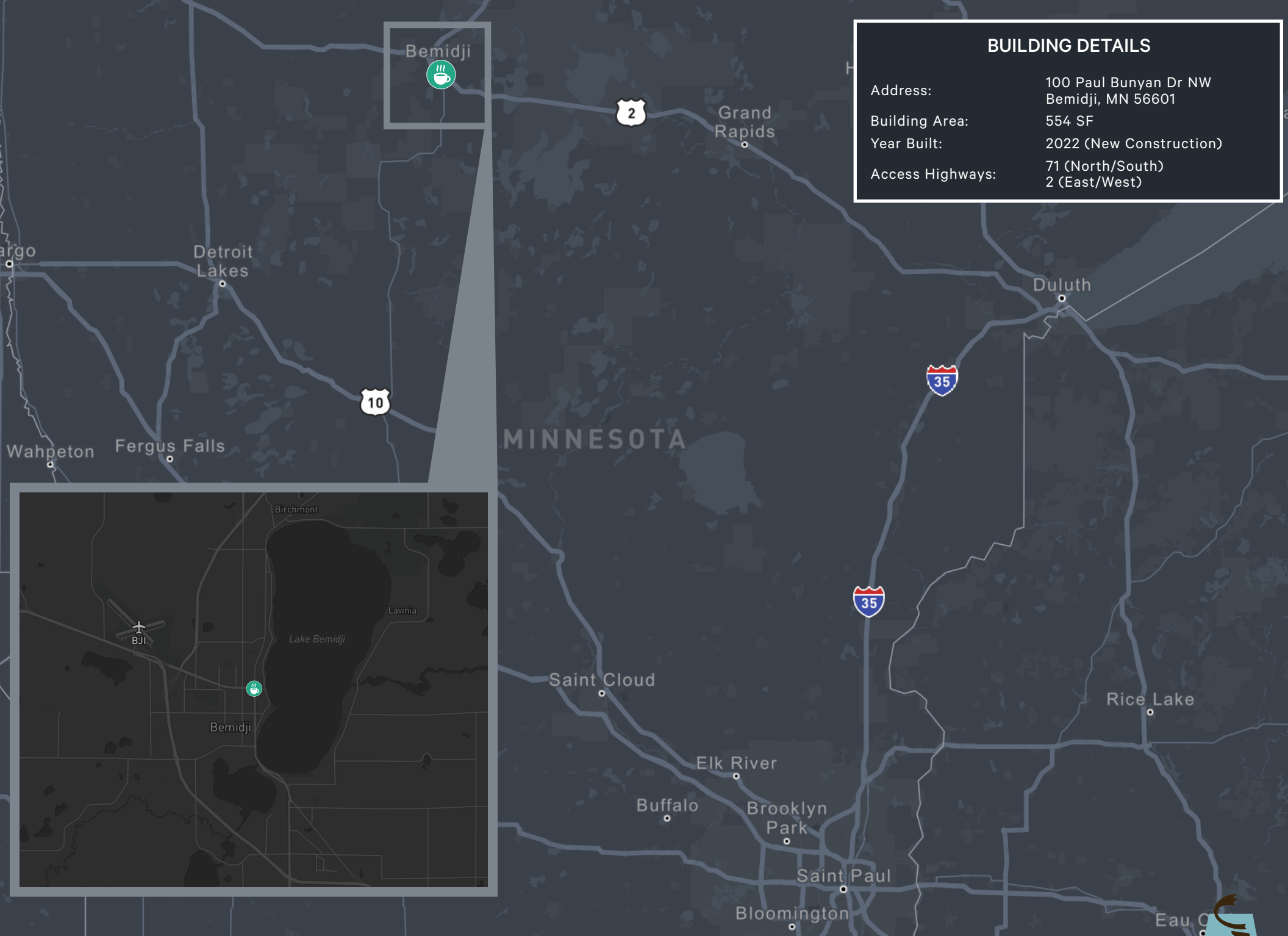

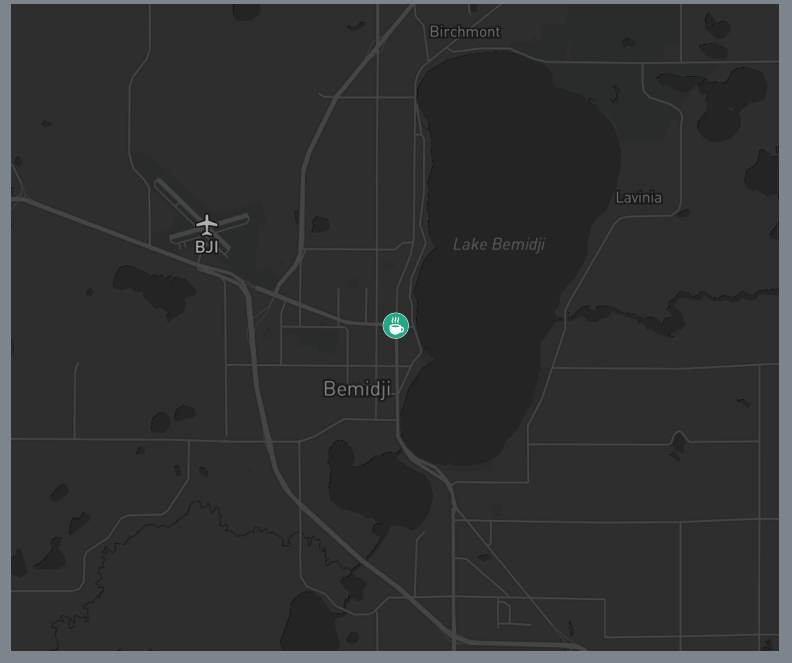

## MARKET SUMMARY

### ECONOMY

Bemidji is located in north central Minnesota at the intersections of U.S. Highway 71 and U.S. Highway 2, approximately 230 miles northwest of the Minneapolis/St. Paul metropolitan area. One of the fastest-growing communities in Minnesota, Bemidji has an estimated population of 22,932, making it the largest commercial center between Grand Forks, North Dakota and Duluth. There are more than 80,000 residents in the (45-mile) Secondary Market Area and nearly 350,000 in the (90-mile) Tertiary Market Area.

As a tourism hub, Bemidji is located near many popular recreational destinations, including Itasca State Park, Lake Bemidji State Park, state forest areas, and the Chippewa National Forest. There are 400 fishing lakes within 25 miles of the city. Over 500 miles of snowmobile trails and 160 kilometers of cross-country ski trails are in and around Bemidji provide abundant winter recreational opportunities. During the summer, more than 25,000 visitors a month stop to take pictures at the iconic statues of Paul Bunyan and Babe the Blue Ox.

### HOUSING

The city of Bemidji sits on the county seat of Beltrami County, in northern Minnesota, United States. Bemidji has an average household income of \$49,089 in 2021, with each home valued at \$141,300

As a central city for three Indian reservations, Bemidji is the site of many Native American services, including the Indian Health Service. Near Bemidji are the Red Lake Indian Reservation, White Earth Indian Reservation, and the Leech Lake Indian Reservation.

### EDUCATION

Bemidji is home to Bemidji State University, a four year liberal arts university with an enrollment of approximately 5,000 students. Bemidji holds many educational programs, including Northwest Technical College, and Oak Hills Christian College. Public education is served by Bemidji Area Schools as a part of Independent School District 31, and includes eight elementary schools, a middle school, and a high school.

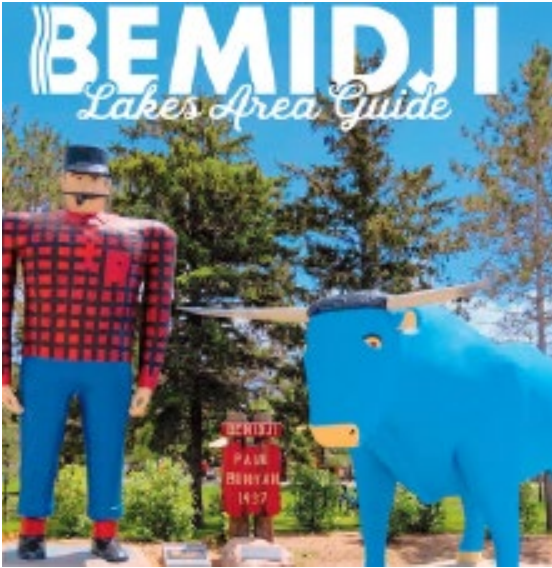
Bemidji is the county seat of Beltrami County and was organized in 1896. The Bemidji Regional Airport represents one of the busiest regional airports in the state, with nearly 30,000 enplanements annually. Bemidji lies on the southwest shore of Lake Bemidji, the northernmost lake feeding the Mississippi River; it is nicknamed "The First City on the Mississippi". Bemidji is also the self-proclaimed "curling capital" of the U.S.

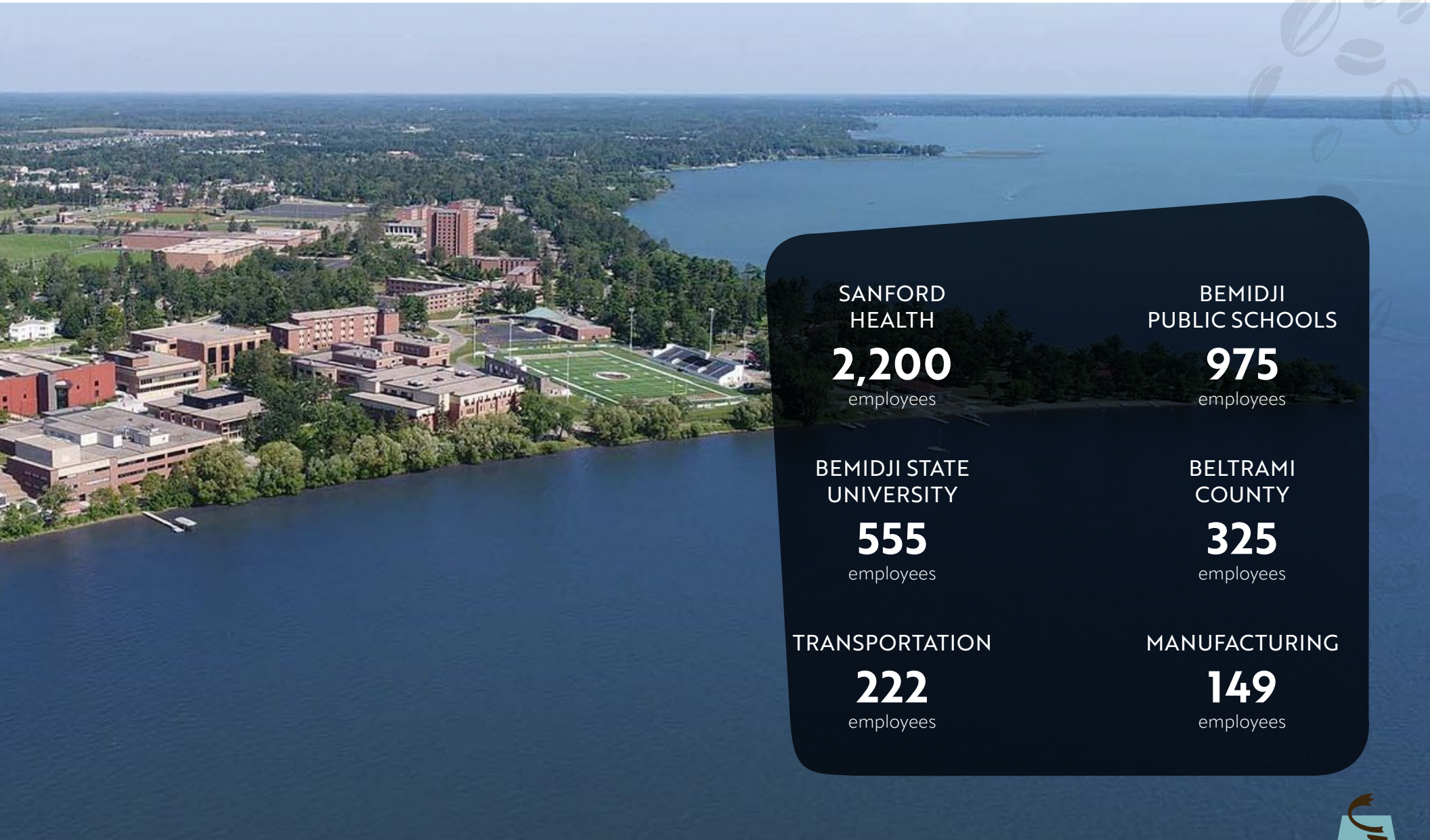
